**ISKCON Inc., the Hare Krishna cult,** built a school system to manufacture homeless beggars,  
**a traditional system in child-slavery, prostitution and begging-based Indian cults.**

Children, toddlers, were tortured in a boot camp-like system of physical pain and self-hate.  
Children are dressed in costumes and prostituted to cult members in daily 5am shows and  
events. Paying cult members and wealthy socialites take possession of children, mostly girls.  
Boys not selected by their own parents are raped of everything in their lives, robbed of their  
homes and inheritances, discarded, shunned, given only the option of cult slavery. First being  
tortured and taught cult methods of suicide, some murdered by converts or trespassed and  
driven to orphan lives, they are robbed of their childhood homes, shunned to silence and killed  
by their parents and cult members; I witnessed.

My father, Hare Krishna's guru, suffered brain and ocular damage from early CRT televisions.  
He developed schizoaffective disorder and accompanying psychopathy, and social disorders. As  
a young adult he was tricked into the \*cult. My father prostituted the previous children of his wife  
to property owning Hare Krishna cult members and rich Indians, and did the same with me.

We had an international \*\*\*lawsuit headed by Windle Turley that began in the late 1990's. It took  
decades to conclude. The cult directors, my guru father, fought tooth and nail to deny victims  
compensation. Homeless victims never received enough to house them. Rejected victims, who I  
knew, never had a chance to add their names to the lawsuit; I witnessed. My guru father is a  
psychopath. He is a person of import in the Hare Krishna cult, as an entertainer of Indian  
fantasy fiction, shiny temples, costumed dolls, dancing girls, child prostitution and victim  
subduction. He profited from human trafficking, and slavery, established child slave-education  
schools and put me there. He preaches the silencing, robbery and murder of victims in the  
name of the cult's founders, dolls and Indian fantasies. He profits from child prostitution and  
human trafficking. He defends the organisation without sympathy. I know. The victims know. The  
uncompensated, the survivors know. ISKCON Inc. and the Hare Krishna's are a satanic cult of  
child prostitution, murder and crime as preached by their \*\*\*founder and practiced to this day.  
The symbols of the Krishna deity are the symbols of infant and child sexual prostitution. The  
ISKCON Hare Krishna cult has a shiny clean facade and show to entertain people. In fact it is a  
cult of a system for crimes against children, slavery, human trafficking, murder & theft for the  
pleasures of perverts and guru criminals growing their wealth and robbing their relatives.
